3. THE ANGLICAN COMMUNION

The Standing Committee in March 2002 considered a communication from the Anglican Communion concerning the Virginia Report and the meaning of "Communion" in the Anglican context. The Virginia Report emanated from the Inter-Anglican Theological and Doctrinal Commission and was a response to a call of the Lambeth Conference of 1988 to consider in some depth the meaning and nature of communion.

A group appointed by the Standing Committee in April 1999 prepared preliminary comments on the Virginia Report and the Standing Committee in March 2002 appointed the same group to respond to the recent communication from the Anglican Communion. The following were appointed:

4. ANGLICAN OBSERVER AT THE UNITED NATIONS

The Ven Taimalelagi F Tuatagaloa-Matalavea was recently appointed Anglican Observer at the United Nations, and requested the Church of Ireland to submit an indication of at least three issues which he, as Anglican Observer should pursue with the United Nations. The following issues were submitted on behalf of the Church of Ireland:

Illegal Immigration Political and Religious Fundamentalism International Illegal Drugs Trade

5. APPEAL TO THE GENERAL SYNOD

The General Synod in 2001 considered an Appeal under Section 32 of Chapter II of the Constitution. The Synod voted not to exercise its right to hear and determine the appeal, but directed that the question be referred to the Court of the General Synod. Questions of a legal nature which have arisen in the course of its proceedings, may be referred to the Court for hearing and determination under Section 26(3) of Chapter VIII of the Constitution.

7. AUDIT OF ACCOUNTS

The Standing Committee appointed PricewaterhouseCoopers to audit the accounts of the Representative Church Body.

8. BISHOPS' APPEAL ADVISORY COMMITTEE

A report from the World Development - Bishops' Appeal Advisory Committee, including accounts for the year ended 31 December 2001, is included as Appendix A on page 143.

The Standing Committee in June 2000 approved in principle the appointment of a Bishops' Appeal Education Advisor for a period of two or three years from 1 January 2001, subject to a commitment for co-funding from Christian Aid. In April 2001 the Standing Committee approved the appointment of the Rev George Pitt to this position in succession to Mrs Bet Aalen. The Standing Committee also authorised the World Development - Bishops' Appeal Advisory Committee to pay the employer's pension contribution to the Church of Ireland Pension Fund in respect of the Education Advisor.

The Bishops' Appeal Advisory Committee was empowered by the Standing Committee to adopt a formal constitution for the purposes of gaining appropriate charitable recognition from the Inland Revenue.

9. CENTRAL COMMUNICATIONS BOARD

A report from the Central Communications Board, which includes the work of the Broadcasting Committee, the Internet Committee and the Literature Committee, is included as Appendix B on page 151.

10. CHRISTIAN STEWARDSHIP COMMITTEE

At the request of the Representative Body, the Standing Committee in January 2002 considered the report from John Truscott on the future of the Christian Stewardship Organisation. The report was commissioned by the Allocations Committee of the Representative Body. The report recommended that notwithstanding the exemplary work carried out by the Stewardship Organisation over the past forty years, a more contemporary approach to giving was needed in future. The Christian Stewardship Central Committee in a response to the report was unanimously in favour of accepting the vision and broad principles of the report.

A small group was appointed to consider the recommendations contained in Part Five of the John Truscott Report and asked to report as soon as practicable. The group consists of two representatives each from the House of Bishops, the Standing Committee and the Representative Body with power to co-opt two more. The Very Rev JMG Sirr and the Rev Canon DP Hoey were appointed to represent the Standing Committee.

11. CHURCHES TOGETHER IN BRITAIN AND IRELAND

The Rt Rev WP Colton, Bishop of Cork, Cloyne and Ross was appointed to serve on the Church Representatives Meeting of Churches Together in Britain and Ireland, in place of the Rt Rev MHG Mayes. Our other representative on the CRM is the Rev RG Gray. The Rt Rev JRW Neill and the Rev DR Nuzum were appointed alternates.

The Assembly of Churches Together in Britain and Ireland met from 26 February to 1 March 2002 in the Hayes Conference Centre, Swanwick. There was also a preparatory meeting for new members on 25 February. The programme for the meeting was entitled "In Search of Holy Ground" and aimed to explore where people today encounter God (recognising that it is not so often through the Church) and how the Churches could make available to them the resources of Christian faith and tradition.

12. CHURCH OF IRELAND YOUTH DEPARTMENT

The Standing Committee received regular reports from the Church of Ireland Youth Department on plans for the future of the organisation. Details are contained in the report of the CIYD to the General Synod.

13. CHURCH IN SOCIETY COMMITTEE

The Standing Committee in January 2001 approved proposals for the establishment of the Church in Society Committee, to replace the former Role of the Church Committee. The proposals were reported to the General Synod in 2001, as an Appendix N to the report of the Standing Committee.

The House of Bishops has nominated the Rt Rev MGStA Jackson as Chairperson of the Committee.

14. CONSOLIDATION OF THE CONSTITUTION

The General Synod of 2001 authorised the Legislation Committee to prepare a Bill to consolidate the Constitution of the Church of Ireland, for consideration by the General Synod in 2002.

In the course of this work, attention was drawn to the reports from the Select Committee on the Canons, which reported to the General Synod in 1973 and 1974. The Committee considered that it was necessary to submit a Special Bill for any amendments being made to certain Canons as these Canons involved the "Articles,

doctrines, rites, rubrics or formularies of the Church". It was considered that the particular Canons in this category, as they appear in the 1988 Constitution, are numbers 5, 6, 10, 12, 13, 16, 26, 31 and 32.

As a Special Bill over two years will be required to amend these Canons, it would not have been possible for the General Synod of 2002 to approve the consolidation of the entire Constitution. Accordingly, the Legislation Committee decided that it is preferable to postpone the Consolidation Bill until 2003 and submit a Resolution to the Synod in 2002 to amend the Canons leading to a Special Bill in 2003.

In order to clear the way further for the Consolidation Bill in 2003, a Bill is submitted in 2002 to include amendments of substance, which could not be included in the Consolidation Bill. These are relatively minor matters which arose in the course of preparing the Consolidation Bill and have been approved by the Standing Committee.

15. DIOCESAN REGISTRARS' FEES

The Rules Committee of Ecclesiastical Tribunals has submitted a report to the General Synod, for the revision of the Schedule of Fees chargeable by Diocesan Registrars and fees for searches in parish registers, which will be laid on the table on the first day of the Synod. Each Diocesan Registrar will receive a copy of the report.

16. DIOCESAN REORGANISATION

Under section 31(2) of Chapter I of the Constitution, the Standing Committee is authorised to approve the transfer of any portion of a diocese to another diocese if requested to do so by the dioceses affected.

As reported last year, the Standing Committee in November 2000 sanctioned the transfer of the parish of Beara Union from the Diocese of Ross to the Diocese of Cork, subject to this request being confirmed by a resolution of the Diocesan Synod, adopted within one year and communicated to the Honorary Secretaries of the General Synod.

It was reported to the Standing Committee in September 2001 that the Diocesan Synod, at a meeting on 9 June 2001, confirmed the request of the Diocesan Council to transfer Beara Union from the diocese of Ross to the diocese of Cork.

17. FUNDING OF ORDINANDS

The Standing Committee referred a letter from Connor Diocesan Council concerning the funding of ordinands to the Representative Church Body and the Theological College Council. In September 2001, the Standing Committee agreed in principle with a proposal from the Theological College Council to establish a fact-finding group to investigate the issue and appointed Mr WF Baker as its representative.

The Theological College Council reported in January 2002 that a fact-finding group had been appointed with Ms C McCutcheon as convenor. The group aims to

produce a preliminary report for the Council by the summer and report to the Standing Committee and other relevant groups thereafter.

18. THE GENERAL SYNOD 2003

In accordance with the authority delegated to the Standing Committee by the General Synod in 1982, the meeting of General Synod in 2003 was arranged for 13, 14 and 15 May in the O'Reilly Hall, University College Dublin.

19. GENERAL SYNOD ROYALTIES FUND

The following allocations were approved:

A grant of IR£1,000 to the APCK to support the publication of a book of millennium essays entitled *A Time to Build* edited by the Very Rev SR White.

A grant up to a limit of IR£5,000 for the publication of the Calendar and Collects, as approved by the General Synod, to enable copies to be supplied to every incumbent, curate, licensed auxiliary minister, Church Army evangelist and diocesan reader in the Church of Ireland.

A grant of IR£3,500 to the APCK to assist in the publication of three pamphlets for distribution – one each on the Bible, The Eucharist and the Blessed Virgin Mary.

A grant of up to IR£2,000 to produce a booklet entitled "A Guide to Ordination" to be available free of charge.

20. GENERAL SYNOD - STANDING COMMITTEE BUDGETS

The Budget Sub-Committee considered budget submissions from various bodies concerning their projected expenditure for the year 2002 and presented a report to the Standing Committee in September 2001. Following consideration of the report, recommendations were submitted to the Representative Church Body Allocations Committee.

The Irish Inter-Church Meeting will take place on 19-20 April 2002 at the Dromantine Conference Centre, near Newry. The main theme will be *Pathways to Peacebuilding* and will deal with issues arising from the work of the Moving Beyond Sectarianism Project of the Irish School of Ecumenics.

The Church of Ireland is entitled to appoint six representatives in addition to our three members on the Irish Inter-Church Committee, who are the Archbishop of Armagh, the Very Rev LDA Forrest and the Rev Dr IM Ellis. 22. IRISH COUNCIL FOR TELEVISION AND RADIO AFFAIRS

A report from the Irish Council for Television and Radio Affairs for the year ended 31 March 2001is included as Appendix C on page 167.

23. LITURGICAL RESOLUTIONS

The General Synod in 2000 amended Standing Order 30 to allow amendments to Special Bills to be submitted up to one month after the first reading stage. This rule applies to amendments to the Schedules of Liturgical Bills.

At present, members of the Synod see these amendments on the agenda paper for the first time on day one of the Synod at the second reading stage of a Special Bill. With the support of the Liturgical Advisory Committee, the Honorary Secretaries decided that a draft list of amendments to the Liturgical Bills be circulated with the Synod papers three weeks before the Synod, which would allow consideration by members before the meeting.

24. MARRIAGE LAW

The Standing Committee in June 2001 endorsed an initial response to the Republic of Ireland Government's document *Bringing Civil Registration into the 21st Century* prepared by the Marriage Law Sub-Committee and authorised the Sub-Committee to enter into further discussion with the Department of Social, Community and Family Affairs.

The Sub-Committee met with the Registrar General on 27 June 2001 and submitted a report on this meeting to the Standing Committee. The initial response and the report on the meeting are included as Appendix D on page 169.

In April 2000, the Church of Ireland submitted a response to a Discussion Paper on reform of Marriage Law in Northern Ireland. The response was prepared by the Advisory Committee on Law Reform, established for this purpose. A report on Marriage Law was published by the Law Reform Advisory Committee for Northern Ireland in December 2000 and the Department of Finance and Personnel is now considering implementing the recommendations contained in the report by way of legislative reform.

The Deputy Registrar General in Northern Ireland, invited submissions on the potential equality impact of the proposed review of marriage law and the Advisory Committee on Law Reform prepared a report which was received by the Standing Committee in November 2001. The report is included as Appendix E on page 175.

As it was felt that clergy will need advice on the changes in marriage law both in Northern Ireland and in the Republic of Ireland, the Standing Committee appointed a small working group to investigate the practical implications of the reform of marriage law in both jurisdictions. 25. THE NATIONAL FORUM ON EUROPE

The government in the Republic of Ireland established the National Forum on Europe to facilitate a broad-ranging and inclusive discussion of issues arising from Ireland's membership of the European Union and questions relating to the debate on the future of Europe. The Church of Ireland was invited to be represented in the Special Observer Pillar at the Forum, which includes non political organisations in the Republic which may have an interest in European affairs.

Dr K Milne was appointed to represent the Church of Ireland in this capacity, being the Chairman of the European Affairs Working Group of the former Role of the Church Committee. The Rev Canon CA Empey was appointed as alternate. A report on the work of the Forum is included as Appendix F on page 178. The report also includes the Church of Ireland submission to the Forum.

26. THE PORVOO COMMUNION

The Standing Committee on 23 January 2001 set up a small *ad hoc* group to consider the recommendations contained in the Concluding Document of the Porvoo Conference held in Durham in September 2000. The Standing Committee agreed that the proposals contained in the report for a plan of action to study youth cultures, be conveyed to the Porvoo Communion. A report from the group is included as Appendix G on page 182.

In November 2001 the Standing Committee received a report on the meeting of the Porvoo Contact Group, held in Haslev, Denmark, in September 2001. The meeting was attended by Ms V Beatty, the Church of Ireland representative on the Contact Group. The report is included as Appendix H on page 185.

The Church of Ireland was invited to send a delegation to visit the Church of Sweden in November 2001. The Standing Committee appointed the Most Rev RHA Eames, the Rt Rev JRW Neill, Ms Valerie Beatty and Mrs Andrea Wills. A report on the visit is included as Appendix I on page 188.

The Porvoo Communion Church Leaders' Consultation held in Tallinn, Estonia from 7 to 12 March 2002 was attended by the Rt Rev JRW Neill, as Co-chairman, Ms V Beatty, as our Contact Group member and the Rev Canon RD Harman. The theme of the Consultation was "Church Leadership in a Changing World" and it covered a number of important issues faced by our Church leaders.

28. PUBLICATION OF PRAYER BOOK ADVISORY COMMITTEE

The Standing Committee in September 2000 established the Publication of Prayer Book Advisory Committee to assist the Rev Canon JAB Mayne as editor of the new edition of the Book of Common Prayer to be published in 2004. A report from the Advisory Committee is included as Appendix J on page 190.

29. THE REUILLY DECLARATION

As the Reuilly Declaration with the French Lutheran and Reformed Churches has been signed, a Contact Group is being established to implement the commitments contained in the Declaration. It is anticipated that the group will meet once a year and will comprise of representatives from the signatory Churches.

The Celtic Churches had agreed to appoint one representative to attend the Reuilly Contact Group on their behalf, with expenses shared accordingly. The Rev John Luckie of the Scottish Episcopal Church has been appointed as the Celtic representative and co-secretary of the Reuilly Contact Group.

30. SECTARIANISM EDUCATION PROJECT

In September 2001 the Standing Committee established the Sectarianism Education Project Committee and Working Group in place of the Sectarianism Steering Group.

It was noted that the Irish School of Ecumenics was already involved in implementing sectarianism education and that existing material produced by the ISE should be used as much as possible. The following resolution was adopted by the Standing Committee:

- 1. That the Steering Group be disbanded.
- 2. That it be replaced by the Church of Ireland Sectarianism Education Project.
- 3. That the Project be organised with two foci:
 - a. A Church of Ireland Sectarianism Education Project Committee of fifteen members be appointed, responsible to Standing Committee for the development and management of the Project with power to co-opt up to three.
 - b. A Working Group of eight members be appointed, responsible to the Project Committee. The Working Group shall consult with the Chief Officer of the RCB on arrangements for the management of resources and staff and shall report at least twice a year to the Project Committee on the development of its programme.
 - c. That the following be appointed to the Church of Ireland Sectarianism Education Project Committee:

4. That the Project Committee be instructed to present an initial report to the Standing Committee in January 2002 on plans for a Sectarianism Education Programme taking into account educational material already available from the Irish School of Ecumenics, Corrymeela, ECONI and other sources. That the Project Committee be instructed to present detailed proposals for a Sectarianism Education Programme to the Standing Committee for approval in January 2003.

In accordance with Part 4 of the resolution, the Sectarianism Education Project Committee reported to the Standing Committee in January 2002, and again in March outlining plans for a scoping study. The study will ascertain the attitudes, needs and experiences of clergy and lay people on the issue of sectarianism. The reports are included as Appendix K on page 192.

The Standing Committee in March 2002 approved the scoping study at a cost of £50,840 as detailed in the document entitled "Scoping Study Project Methodology", which is included as Appendix L on page 196. A Consultancy Agreement with Dr Gareth Higgins to implement the scoping study was also approved.

The International Fund for Ireland has agreed to grant a sum of £32,840 towards the cost of the scoping study, which the Standing Committee agreed to accept. A sum of £20,000 was allocated from the Priorities Fund.

31. THE STANDING COMMITTEE AND THE REPRESENTATIVE BODY

The Standing Committee agreed in principle to permit the Chief Officer and Secretary of the Representative Body to attend and speak at meetings of the Standing Committee. The Representative Body approved this proposal in the interests of closer co-operation in relation to financial issues, resources and priorities.

The Representative Body agreed a corresponding right of attendance, and right to speak, at meetings of the Representative Body of two of the Honorary Secretaries of the General Synod and of one at meetings of the Representative Body's Executive Committee. The Honorary Secretaries appointed the Rev Canon RD Harman and Lady Sheil to attend the meetings of the Representative Church Body and Canon Harman to attend meetings of the RCB Executive Committee.

32. TERRORIST ACTION IN THE UNITED STATES

The Standing Committee in September 2001 prayed for the families of those who died and those injured as a result of the terrorist action in the United States on 11 September. The following resolution was forwarded to the Provincial Secretary of the Episcopal Church of the United States of America:

The members of the Standing Committee of the General Synod of the Church of Ireland express their sincere regret and sorrow at the horrific destruction and loss of life in the United States on Tuesday 11th September 2001 caused by terrorist action and offers the sympathy of the Church of Ireland to all who have been bereaved and injured. The Standing Committee also wishes to record its support for the words of the Presiding Bishop of the Episcopal Church, the Most Revd Frank Griswold, in his plea for a way forward other than that based on emotions of rage and revenge.

The Provincial Secretary of the Episcopal Church of the United States of America has thanked the Standing Committee for the message of sympathy to all those bereaved and injured in the terrorist attack and indicated that the resolution will be brought to the attention of the relevant committee of the Episcopal Church of the United States of America.
