Explanatory Memorandum

In 2001 various texts were excluded from consideration at the committee stage to give General Synod the opportunity to consider all the proposals of the international English Language Liturgical Consultation. These are texts of prayers, creeds and canticles which are common to all churches which use English in their liturgies. This was because it was understood that these texts might be subject to amendment at the ELLC 2001 meeting. In fact no changes were made and the texts were submitted as a resolution in 2002. An amendment was made by the Liturgical Advisory Committee to the wording of the Nicene Creed which follows the traditional language version in translating the original Greek of one line as 'he became incarnate by the Holy Spirit of the Virgin Mary'. This is because both 'by' and 'of' are the same Greek word.

The following Preface shall be inserted immediately before the Preface prefixed at the Revision of 1926:-

THE PREFACE

PREFIXED AT THE REVISION OF 2004

In 1997 the General Synod of the Church of Ireland, after careful consideration, requested the Church's Liturgical Advisory Committee to prepare a new edition of the Book of Common Prayer. Since disestablishment, two previous editions of the Book of Common Prayer had been produced (in 1878 and in 1926), but this new Book of Common Prayer was to include not only services of the Church handed down through the centuries but also services in contemporary language. In three decades prior to 1997 the General Synod had authorised a large number of services in modern language as alternatives to those contained in the Book of Common Prayer and thus this book, now given to the Church, represents the cumulative labours of committee and of Synod over many generations.

In undertaking our task, we embraced a time-honoured vision of Common Prayer which informs the contents and presentation of this book. We sought to unify the worship of God's people, while allowing reasonable scope for diversity within the essential unity of the Church's prayer. We were determined to produce a book which would have equal capacity to enrich private as well as corporate devotion. We desired that this book, like previous editions of it, should properly articulate and embody the Church's faith. We hoped that the book would strengthen our bonds of unity with sister churches who share our approach to Common Prayer, and we were therefore fully attentive to the reports of successive meetings of the International Anglican Liturgical Consultation.

We trust that this book will be used and treasured by many congregations and individuals in the years to come, and that its contents will permeate and shape their experience of prayer. Nevertheless, we must always remind ourselves that words, however admirable, beautiful or useful, are never to be confused with worship itself. The words set out on these pages are but the beginning of worship. They need to be appropriated with care and devotion by the People of God so that, with the aid of the Holy Spirit, men and women may bring glory to the Father and grow in the knowledge and likeness of Jesus Christ.

This book therefore leaves its compilers' hands with the hope and prayer that it will prove to be a worthy instrument by which to proclaim the Church's praise of God in the generation to come. It is of course only by God's gift that his faithful people 'do him true and laudable service', but we pray also that this book will have the capacity to draw God's people in our time to a fresh experience of the beauty of holiness.

Explanatory Memorandum

In the year 1999, the General Synod passed the first statutes of a long series of liturgical legislative provisions which have been considered by Synod over the following three years; the provisions of these statutes, when brought fully into operation will, together with the provisions of various enactments already in operation, form part of the *Book of Common Prayer* (2004), the third edition of the Book since the disestablishment of the Church of Ireland.

Accordingly, clause 1 and Schedule I seek to provide that 6 June 2004 (Trinity Sunday 2004) shall be the date of commencement for the relevant provisions of the various liturgical statutes of 2000-2003.

In clause 2 the order of offices is listed. In this order, where, in a few instances such as Morning and Evening Prayer, a service is listed as 'ONE' or 'TWO' this is simply for ease of reference and in each case 'ONE' will refer to traditional the language version of the service and 'TWO' to the service in *Alternative Prayer Book* (1984) form as amended in the light of practical usage and of recent liturgical scholarship. In all cases the relevant services are as approved by General Synod.

Finally, in clause 3 and Schedule II provision is made for the repeal of several liturgical statutes which, by virtue of the provisions of the 2004 edition of the *Book of Common Prayer*, will become redundant. These statutes made provision for services which were originally included in *Alternative Occasional Services* (1993) and which in a revised form have now been included in and so superceded by the *Book of Common Prayer* (2004).

LADY SHEIL REV CANON RB ROUNTREE

BILL

To bring into operation the provisions of certain statutes of the General Synod and to make provision for ancillary matters concerning the 2004 edition of the *Book of Common Prayer*

WHEREAS it is desirable that the provisions of several statutes of the General Synod in the years of 2000, 2001, 2002 and 2003 shall be brought into operation to form part of the 2004 edition of the *Book* of Common Prayer;

AND WHEREAS it is desirable that the said edition of the *Book of Common Prayer* shall have an order of offices;

BE IT ENACTED by the Archbishops and Bishops and the Clergy and Laity of the Church of Ireland in General Synod assembled in Dublin in the year 2003, and by the authority of the same, as follows:

Such provisions of the statutes set out in Schedule I which are not already in operation shall come into operation on 6th June, 2004 to form, together with the provisions of Chapters I and II of 1999 and of Chapter III of 2001, part of the 2004 edition of the *Book of Common Prayer*.

- 20. Christian Initiation ONE (a) The Ministration of Public Baptism of Infants to be used in Church.

Explanatory Memorandum

During the past five sessions of General Synod a large number of statutes providing new forms and orders of service in both traditional and modern language have been passed. During those years a number of inaccuracies and inconsistencies have arisen between the different orders of service. This bill seeks to correct these as well as to simplify and remove duplication which occurred when presenting separate services in legislation.

In addition it was discovered that there were errors in the provision of readings for festivals etc. Opportunity is taken to re-visit a number of these provisions to harmonize the Church of Ireland provision with that of the sister churches of Wales and England.

LADY SHEIL REV CANON RB ROUNTREE

(at the request of the General Synod)

BILL

To carry into effect a Resolution of the General Synod of 2002 to correct inaccuracies and contradictory directions and to remove infelicities of diction in the statutes set out in the accompanying Schedule, which statutes will form part of the text of the 2004 edition of the *Book of Common Prayer*

WHEREAS a Resolution to amend the *Book of Common Prayer by* correcting inaccuracies and contradictory directions and removing infelicities of diction in the Statutes set out in the accompanying Schedule, was duly passed in full Synod assembled in Dublin in the year 2002, by the required majorities, and was duly transmitted to the Secretaries of all Diocesan Synods;

AND WHEREAS it is expedient that the said Resolution shall be carried into effect by a Statute;

AND WHEREAS in accordance with the provisions of section 26(1) of Chapter 1 of the Constitution leave was given for the introduction of a Bill in the General Synod of 2003;

BE IT ENACTED by the Archbishops and Bishops and the Clergy and Laity of the Church of Ireland in General Synod assembled in Dublin in the year 2003, and by the authority of the same as follows:

In the 2004 edition of the *Book of Common Prayer*, the provisions of the statutes set out in the accompanying Schedule shall be amended in accordance with the said Schedule.

Explanatory Memorandum

In 2002 the General Synod approved by the required majorities a resolution granting leave for the introduction of this Special Bill in 2003.

The General Synod of 2001 authorised the preparation of a Bill to consolidate the Constitution of the Church of Ireland so replacing the statute of 1988 and that Bill is Bill No 15 of 2003. In order that inclusive language may be used throughout the Constitution, Bill No 15 will include, as does the Statute of 1988, certain definitions.

One such definition, to replace the definition in section 2(1)(b) of the Statute of 1988 will be that the term 'member of the clergy' or 'clergy' shall, unless otherwise specifically provided, mean a deacon or priest of the Church of Ireland or of a church in full communion with that Church.

Chapter IX of the Constitution contains the Canons of the Church of Ireland and since an amendment to any of the Canons which concern the 'Articles, Doctrines, Rites, Rubrics or Formularies of the Church' requires a Special Bill, under section 26(1) of Chapter I of the Constitution, this Bill is now before the General Synod of 2003 so that the amendments therein, to ensure inclusive language, may be included in the consolidation of the Constitution in 2003, as found in Bill No 15 and the Schedule thereto.

LADY SHEIL THE HON MRS JUSTICE C MCGUINNESS

(at the request of the General Synod)

BILL

To carry into effect a Resolution of the General Synod of 2002 to amend, in Chapter IX of the Constitution, Canons 5, 6, 10, 12, 13, 16, 26, 31 and 32 (hereafter referred to as "the said Canons") of the Canons of the Church of Ireland by substituting, for the said Canons, the Canons set out in the accompanying Schedule.

WHEREAS a Resolution, to amend in Chapter IX of the Constitution the said Canons by substituting, for the said Canons, the Canons set out in the accompanying Schedule, was duly passed in full Synod assembled in Dublin in the year 2002 by the required majorities, and was duly transmitted to the Secretaries of all Diocesan Synods;

AND WHEREAS it is expedient that the said Resolution shall be carried into effect by a Statute;

AND WHEREAS in accordance with the provisions of Section 26 (1) of Chapter I of the Constitution leave was given for the introduction of a Bill in the General Synod of 2003;

- 1. In this Statute Chapter IX means Chapter IX of the Constitution of the Church of Ireland.
- 2. In Chapter IX for the said Canons there shall be substituted the Canons set out in the Schedule to this Statute.

Bill No 15

Explanatory Memorandum

The General Synod of 2001 authorised the Legislation Committee to prepare a Bill to consolidate the Constitution of the Church of Ireland.

A consolidation does not permit substantive amendments and accordingly certain amendments of substance which could not be included in this Consolidation Bill were brought before General Synod in 2002 in what has become Chapter IX of 2002. Those amendments, together with the amendments of Bill No 14, a Bill for the introduction of which leave was given by General Synod in 2002, are included in the Schedule to this Bill which Schedule constitutes the Consolidation of the Constitution of the Church of Ireland.

In order that inclusive language may be used throughout the Constitution, Clause 2 of this Bill includes, as did the relevant Statute of 1988, certain definitions. As General Synod of 2002 was advised, one such definition, to replace the definition in Section 2 (1) (b) of the Statute of 1988, will be that the term 'member of the clergy' or 'clergy' shall, unless otherwise specifically provided, mean a deacon or priest of the Church of Ireland of a church in full communion with that Church.

As was done in 1988 in respect of the previous consolidation, it is proposed that the 2003 Constitution will come into effect, not on enactment, but on 1st October 2003. This is to ensure that the amended text, in inclusive language and incorporating the usual Appendices and an updated and revised Index, may be readily available in printed and electronic form on that date.

LADY SHEIL THE HON MRS JUSTICE C MCGUINNESS

(at the request of the General Synod)

BILL

To consolidate enactments in regard to the Constitution.

WHEREAS it is expedient to consolidate enactments of the General Synod in regard to the Constitution of the Church of Ireland and for that purpose to repeal the Constitution of the Church of Ireland, 1988 (save as regards the Preamble and Declaration prefixed thereto and the Rules annexed to Chapter XIII thereof), as amended by subsequent Statutes of the General Synod.

BE IT ENACTED by the Archbishops and Bishops and the Clergy and Laity of the Church of Ireland in General Synod assembled in Dublin in the year 2003, and by the authority of the same as follows:

- 1. From and after 1st October 2003 the several provisions contained in the first Schedule to this Statute shall be in force in the Church of Ireland and the said Schedule shall be read and construed as part of this Statute.
- 2. In the said Schedule and in any Statute amending the same

the term "Constitution" shall mean the said Schedule with such amendments thereof as from time to time for the time being shall be in force;

the term "Statute" shall mean a Statute of the General Synod;

the term "Representative Body" shall mean the Body to represent the Church of Ireland and to hold property for the uses and purposes thereof called in the Irish Church Act, 1869, the Representative Body of the said Church;

wherever the context so admits the word "diocese" shall include any diocese or united diocese or united dioceses under the jurisdiction of one bishop;

the term "member of the clergy" or "clergy" shall, unless otherwise specifically provided, mean a deacon or priest of the Church of Ireland or of a church in full communion with that Church.

3. From and after 1st October 2003 the several Statutes and portions of Statutes mentioned in the second Schedule to this Statute shall be and the same are hereby repealed: Provided always that such repeal shall not invalidate or affect any act or thing heretofore done or any right or liability heretofore acquired or incurred under or in pursuance of the provisions hereby repealed.

Bill No 16

Explanatory Memorandum

The purpose of this Bill is to give effect to the proposals contained in Appendix A to the Report of the Representative Body arising from the provisions of the Statute passed by the General Synod in 2001 to provide for the establishment of Provincial Mediation Panels and related matters.

MR S GAMBLE MOST REV JRW NEILL

BILL

To provide for the establishment of a Severance Fund for clergy.

WHEREAS it is expedient to make provision for the establishment of a Severance Fund for clergy;

AND WHEREAS for such purpose it is desirable that a contribution towards the financing of the Severance Fund be raised within each diocese;

Be it enacted by the Archbishops and Bishops and the Clergy and Laity of the Church of Ireland, in General Synod assembled in Dublin in the year 2003, and by the authority of the same, as follows:

1. From 1st January 2004 each diocese shall contribute towards the cost of the Severance Fund at a rate to be determined by the Representative Body not later than 30th June in 2003 and each year thereafter:

Provided that a rate determined for any one year being more than twenty-five *per centum* in excess of the rate for the year immediately preceding shall become operative only on the passing of an affirmative resolution of the General Synod.

- 2. (1) The contribution from each diocese shall be the sum of the number of cures, including vacant cures, in such diocese at the preceding 30th June (as agreed between the Representative Body and the diocesan council) multiplied by the minimum approved stipend of an incumbent as fixed from time to time by the General Synod in accordance with Section 51(1) of Chapter IV of the Constitution of the Church of Ireland and operative on 1st January of the year to which the contribution relates multiplied by a rate *per centum* determined by the Representative Body in accordance with clause 1.
 - (2) In the case of a diocese, part of which is situated in the Republic of Ireland and part of which is situated in Northern Ireland, account shall be taken of the differing figures for minimum approved stipend fixed in respect of incumbents resident in each jurisdiction and the contribution shall be subdivided accordingly.
 - (3) In the event of disagreement between the Representative Body and the diocesan council as to the number of cures in any diocese, such shall be determined by the decision of the archbishop of the province in which such diocese is situated.
- 3. Contributions shall be payable quarterly in arrears by each diocesan council on 31 March, 30 June, 30th September and 31 December each year or in such other manner as the Representative Body may approve.

- 4. Each diocesan council shall be at liberty to recover in whole or in part the contribution so charged by direct assessment on the individual parishes, unions or groups of parishes, or churches, within its jurisdiction in whatever manner it deems appropriate.
- 5. For the purposes of this Statute the term 'cure' shall have the same general meaning as contained in Chapter IV of the Constitution of the Church of Ireland, and shall include:
 - (a) A parish, union or group of parishes under the care of an incumbent appointed under Part III of Chapter IV;
 - (b) A parish, union or group of parishes under the care of a bishop's curate appointed under Section 42 of Chapter IV;
 - (c) A parish, union or group of parishes assigned to the immediate care of a vicar appointed under Part X of Chapter IV;
 - (d) A parish, union or group of parishes in respect of which a certificate has been issued by the Representative Body under Section 52 of Chapter IV;
 - (e) A "light-duty parish" as defined by Section 62 of Chapter IV;
 - (f) A cathedral which is non-parochial.
- 6. The Representative Body shall at the ordinary session of the General Synod in 2008 and quinquennially thereafter, and may at any other session, present a report on the implementation of this Statute, specifying any amendment which may appear to be necessary or expedient.

Bill No 17

Explanatory Memorandum

The present regulations governing summoning of Boards of Nomination preclude a Board from meeting until such time as the cure concerned becomes vacant. They date from a period when voluntary retirement of clergy was unusual and compulsory retirement non-existent and when it was not uncommon for incumbents to remain in office until death. They also assume the ready availability of clergy, and relatively short vacancies.

In changed circumstances, where none of the above now apply and vacancies of long duration are common, it would seem desirable to enable the process of filling vacant incumbencies to begin at the earliest possible date. The Bill seeks to make provision for a Board of Nomination to meet in circumstances of a prospective vacancy, where, for instance, an Incumbent has indicated his or her intention to resign or retire on a particular date.

MR WF BAKER VEN REB WHITE

BILL

to amend Chapter IV of the Constitution

WHEREAS it is expedient that a Board of Nomination should be entitled to meet before a vacancy in a cure has actually occurred;

AND WHEREAS for that purpose it is necessary to amend Chapter IV of the Constitution;

BE IT ENACTED by the Archbishops, Bishops and the Clergy and Laity of the Church of Ireland in General Synod assembled in Dublin in the year 2003, and by the authority of the same, as follows:

1. In Chapter IV of the Constitution (hereinafter referred to as 'the said Chapter') immediately after the words 'APPOINTMENT TO AND TENURE OF CURES' there shall be inserted the following:

"Preliminary

In Parts I, II and III the terms 'vacant cure', 'vacant benefice', 'vacancy in a cure of souls' and 'a cure becoming vacant' shall include a cure where the vacancy is prospective and, as far as can reasonably be ascertained, definite."

2. For Section 15 of the said Chapter there shall be substituted:

"15. Subject to the provisions of Sections 13 and 14 of this Chapter, the Board of Nomination for a vacant cure shall be summoned by the Bishop, or the Bishop's Commissary, to meet on a date which is not earlier than three months before the date on which the cure will, as far as can reasonably be ascertained, become vacant and which is not later than two months after the date of receipt by the Bishop or the Bishop's Commissary of the report required by Section 13 of this Chapter."
